# A coordinated approach

As we advance on the journey towards the 2025 UN High-Level Meeting on NCDs, the NCD Alliance continues to lead and amplify the global call for stronger action on noncommunicable diseases. The 2024-2025 Global Week for Action on NCDs, under the banner of **Leadership**, embodies the strength and resilience of our community. In 2024 we saw more than 400 impactful activities from members and partners across the globe. From virtual and in-person events to the launch of two inspiring microdocumentaries, Raise Your Voice from Malawi and Going Full Circle from India, advocates came together to spotlight the urgent need for leadership in tackling NCDs.

NCDA's road to the HLM4 is guided by three complementary campaign streams:

The first of these, Global Advocacy, centres on our engagement with WHO-led processes, ensuring that civil society is united on the road to 2025 advocating for a strong Political Declaration. The second, Global Mobilisation, drives the Global Week for Action, bringing together voices across sectors to push for enduring change. The third, Global Convening, sets the stage for the Global NCD Alliance Forum in February 2025. This event will serve as a springboard, accelerating our campaign and reinforcing our collective resolve.

These keys are the foundation for long-term progress, holding governments accountable, and building a future in which health equity is achievable for all. With the incredible momentum generated by our NCD Champions and the overwhelming engagement across social media in 2024, it's clear that our movement is gaining strength.

The Global Week for Action on NCDs (GW4A) unites the NCD community every year, concentrating our combined efforts to help reduce the NCD burden globally and improve health and equity for all. This communications campaign is created around five NCD gaps identified by the NCD movement in 2020.

For this special two-year edition, the campaign is highlighting the need for Leadership on NCDs in the lead up to the Fourth United Nations High-Level Meeting on NCDs. We are focusing on five priority areas where governments must show leadership.

# The call to action: **NCD Alliance** advocacy priorities

The NCD Alliance has identified five advocacy priorities for the fourth **United Nations High-Level Meeting** on the Prevention and Control of **Noncommunicable Diseases:** 



## **ACCEL FRATE IMPLEMENTATION**

Fast-track national implementation of evidence-based NCD policy recommendations to achieve progress on health and well-being for all, focusing first on those left furthest behind.



## **BREAK DOWN SILOS**

Bring NCDs to the centre of global health and development agendas to consolidate efforts and achieve more through integrated action.



## **MOBILISE INVESTMENT**

Provide sustainable financing for NCDs across the full continuum of care that is sufficient to match the disease burden.



## **DELIVER ACCOUNTABILITY**

Track, measure and fulfil commitments on NCD prevention and care in the lead up to 2025, 2030 and beyond.



## **ENGAGE COMMUNITIES**

Put people at the heart of the NCD response, engaging civil society, communities and people living with NCDs in decision-making and implementation.

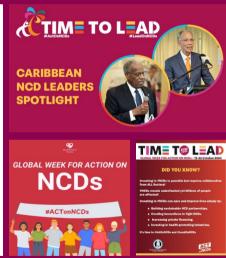

## **Short Films**

To kick-off the week, the NCD Alliance launched two short films spotlighting the impactful stories of local leaders advocating for better NCD care in their communities.



"Going Full Circle" gives a view into life for women living with diabetes in India, and the myriad of social, emotional and economic challenges that go beyond managing blood sugar.







"Raise Your Voice" is filmed in Malawi, where NCDs such as cancer and diabetes are still relatively new as a major health burden. Limited access, low investment and long distances to medical clinics contrast dramatically with the healthcare provided in high-income countries.

It calls on Member States to take decisive action at the Fourth UN High-Level Meeting on NCDs in September 2025, and will be delivered to world leaders ahead of the gathering.

## **ACCELERATE IMPLEMENTATION**

by delivering the proven, cost-effective policies to reduce NCD risk factor exposure, integrating quality NCD interventions into person-centred care and universal health coverage benefit packages, and expanding access to essential NCD medicines, technologies, and resources.



### **MOBILISE INVESTMENT**

by increasing sustainable funding for health that includes specific and measurable financing targets for NCDs strategies and maximises the win-win from health taxes and other fiscal measures.



## **DELIVER ACCOUNTABILITY**

by regularly monitoring and reporting to citizens and the global community on an updated set of NCD targets extended to 2030 and beyond; and by integrating NCD commitments into the post-SDG agenda.



# **Looking Ahead**

This campaign would not be possible without the continuous support of the NCD community, demonstrating that we can achieve greatness when we come together with a shared goal. Thanks to the dedication of national alliances, community groups, and advocates worldwide, this year's Global Week for Action on NCDs has set the stage for a transformative journey towards a healthier, more equitable world.
